- (a) *The Candidates with 104 weeks of practical work experience under a Corporate Member of SLIA **after successful completion** of SLIA Professional Practice Examination - Part I and **52 weeks** of full time practical work experience under a Corporate Member* of SLIA **after successful completion** of SLIA Professional Practice Examination - Part II.*

OR

- (b) *The Candidates with **104 weeks of full time** practical work experience under a Corporate Member* of SLIA **after successful completion** of B.Sc. (Built Environment) degree or equivalent of which **52 weeks** should be **after successful completion** of M.Sc. (Architecture) degree or equivalent as recognized by the SLIA.*

OR

- (c) *The Candidates with **104 weeks of full time** practical work experience under a Corporate Member* of SLIA **after successful completion** of B Arch degree or equivalent as recognized by the SLIA.*

INSTRUCTIONS TO CANDIDATES:

1. *Read the instruction carefully before filling this application.*
2. *All Prospective Candidates hoping to sit the Professional Practice Examination - Part III should register themselves with the SLIA as and when notified by the BAE of the SLIA through a press notice or SLIA website.*
3. *It is a requirement under the SLIA regulations governing the examinations that the Candidates work experience should be monitored by the SLIA. For this purpose the SLIA has appointed Practical Training Counselors to whom the Candidates will be assigned by the BAE.*
4. *Candidates registering for Part III examination shall work under a corporate member of SLIA having minimum 5 years of experience after becoming a corporate member. Candidates' experience shall be entered in the prescribed Log Sheets in duplicate and the originals submitted to the Practical Training Counselor monthly.*
5. *Work experience of Candidates duly recorded in Log Sheets will be accepted only for periods **after the successful completion** of SLIA Part I, Part II and B.Sc. (B.E), M.Sc. (Arch.) or B. Arch. Examinations or equivalent as applicable. Date given in the result sheet/transcript issued by the Chairman, BAE/Head of Institution would be considered as the date of completion of the relevant examinations. In order to avoid any confusion in the processing of applications the Candidates are **strictly advised NOT to submit** any Log Sheets detailing experience prior to obtaining the above qualifications.*

6. Periods of work experience less than 20 consecutive weeks in a particular architectural practice shall not be counted towards the total prescribed minimum period.
7. Certified daily diaries providing detailed descriptions of the day to day activities during the periods of practical Training should be maintained and submitted when requested.
8. All advice pertaining to practical training log Sheets should be obtained from the Practical Training Counselors except matters relating to policy.
9. All photocopies of the certificate/documents produced for verification should be clear & legible. Photocopies not accompanied by the originals will be rejected. The applicants should ensure that the rubber stamp of the Registrar is placed on each any every copy of the certificate produced certifying their authenticity.
10. Applicants should pay the Registration fees to the SLIA Secretariat. **Duly perfected application should be personally handed over to the Registrar, SLIA. Incomplete applications WILL NOT be accepted.**
11. The Hony. Secretary, Board of Architectural Education should be contacted for any relevant information regarding the above examination.
